I am indebted to the efforts of Rt. III. Companion James Reid, Grand Historian, to locate and provide this "letter-book" for the period 1874-1882. This letter-book was compiled by Rt. III. Companion James Bower Nixon (GM 1922-1925) during his years as Grand Recorder of the (first) Grand Council of Royal and Select Masters of Ontario, DDGM of Toronto District, Grand Superintendent of Toronto District RAMO and Grand Recorder of the Imperial Grand Conclave of the Red Cross of Constantine. While it is unclear whether later letter-books existed, or whether there was more than one in use at any particular time, the copies of the letters show the early work of the (first) Grand Council and its expansion eastwards (into Quebec) and westwards (Manitoba, Saskatchewan, Alberta and British Columbia).

Perhaps, with time, the copies of the Cryptic Rite Proceedings, referred to in the letter book, will be located.

The letter-book measures slightly larger than the 8½ x 11 inch pages it contains. The book is bound with cardboard and a leather spine: the spine is deteriorating slowly with the passage of time. There are two parts to the book itself - the first part consisting on pages alphabetically indexed and the second obviously holding letter pages, carbons and onion skin duplicate pages for the present, existing, copy.

The alphabetical listing pages contain handwritten names of individuals and names of towns beside the names. This is followed by numbers. The purpose of this section is unknown and as the towns range across Canada, USA and England, they may indicate places of origin of the people listed. The numbers do not appear to be amounts of money or dates. The bottom line is that the use of this section is unknown at present. It has not been transcribed.

The second section contains onion-skin copies of the letters on pages which are sequentially numbered from 1 to 191 but as there are several places where pages have been torn out, it is likely the numbering reached 200 pages. When reading these letters, transcribed on the following pages, it is important to bear in mind the following:

- Dating is shown as month and day and only the last digit of the year. Thus "September 14" becomes "September 14, 1874".
- the Dispensation of September 17, 1874 confirms the year "4" as 1874 and that Daniel Spry was then Grand Master.
- the copies are written on pages numbered sequentially from 1 to 191.

In preparing the transcripts I have shown a "[Source:]" listing the page in the letter-book where the original copy may be found. I have also indicated where pages are missing. In case a reader thinks the formatting to be a problem, I should note that I have tried to reflect the format and style adopted by James Bower Nixon when writing the original letters — punctuation and capitalization is often missing.

While much of the letters are mundane and deal with administration of a growing Grand Council, they provide an insight into the working of the Grand Council and I hope that readers will get some enjoyment.

Summarizing the Contents of the Letter-Book

So, what does the ledger-book tell us about early life in the (new) Grand Council of Ontario? Quite a number of matters, including the following which are flagged for general interest:

- Our Grand Recorder of the day, Right Illustrious Companion James Bower Nixon, was an active Mason and was, in 1874, First Principal of his Chapter (see transcripts of his letters on Chapter matters) and, by 187--- he was DDGM of his Craft District (see transcripts of). On August 10, 1875, with the formation of the Imperial Grand Council of the Red Cross of Constantine of Canada, R. Ill. Comp. Nixon had became the first Grand Recorder and the volume of correspondence on this Order increases noticeably.
- 2. The following is a brief summary of the contents of the letter-book. It should be borne in mind that the (first) Grand Council of Ontario was formed on August 8, 1871. The first Grand Recorder was R. III. Comp. Robert Ramsay of Orillia (a member of Shekinah Council No. 1) who held the office until August 1872 when R. III. Comp. Thomas Sargant (a member of Adoniram Council No. 2) occupied the office for two years. From August 1874 until the Assembly of 1879 (no firm date is known) R. III. Companion James Bower Nixon held the office. Thus the period covered by the letter-book which refers to Cryptic Rite matters is roughly the same with Craft and Royal Arch matters predominant in the last two years.
- 1874 41 items of which: two letters relate to the exchange of representatives with "foreign Grand Councils" (Arkansas) and 1 copy of a Commission (Kansas); 12 letters to Council Recorders requesting the names of officers and members (i.e. the annual return details) for inclusion in the Annual Proceedings; one Dispensation to install a Companion as TIM who had not served a year as Deputy Master and a Companion as DM who had not served one full year as PCW and one letter covering the transmission of the dispensation to the Council concerned; seven letters advising Councils that Grand Council Certificates were ready to be issued on receipt of payment for them; one letter agreeing to lend a Companion the "only" copy of the ritual for Super-Excellent and Red Cross degrees on the understanding that they were to be returned within a short period of one or two weeks and one letter regarding efforts to startup new Councils (Peterborough). The balance covers a range of "low-level" administrative matters of the Grand Council.
- 1875 87 items which begin to include correspondence dealing with the Craft (3) and Royal Arch (3). The remainder refer to the Cryptic Rite: 24 letters (slightly under one-third of correspondence) relate to the exchange of representatives with "foreign Grand Councils" (Minnesota, Michigan, Wisconsin, Alabama, Iowa, Nebraska, Ohio, Florida, Indiana Connecticut, Texas, Mississippi, Kentucky, Oklahoma, California) although the reply from Texas precluded any relationship as the Grand Council had subsumed itself into the Grand Chapter of Texas to which should be added 8 letters (5 sending Proceedings to other Grand Councils and 3 requesting a copy of a "foreign" Constitution to be used as reference for revisions to the Ontario Constitution). Of the balance of the two-thirds: 10 were requests for information on the officers and members of Councils for both the maintenance of the Grand Council Register and also for inclusion in the Annual Proceedings, 5 receipts for fees and dues from Councils, 3 series of letters dealing with arrangements for the institution of Cryptic Council, Peterborough, Ninevah Council, St. Thomas and Morris Council, Perth, 1 Dispensation to form a Lodge of Royal Ark Mariners in London, 1 Dispensation to confer four degrees on a Companion at one meeting (RM, SM, SEM and Red Cross), 3 letters dealing with the loan of his personal copy of the work (RM & SM as well as SEM), 1 letter advising a Council to have at least two of their members made honorary members of other Councils so that "three Councils" would be represented when required (eg installations), 1 letter inviting an American Council to visit Adoniram Council, Toronto, 2 Dispensations to install a Companion as DM who had not served one full year as PCW, 1 Dispensation to hold immediate election and install a new TIM as the incumbent had removed from

the Province, 1 letter re appointment as Inspector General (Manitoba), and 1 letter reports on the move to form the Council of Rites of Canada.

- 1876 75 items of which 2 refer to Craft matters, 2 to Grand Chapter and Royal Arch matters and 14 to the Red Cross of Constantine. The balance, 57 items, refer to the Cryptic Rite. Of these, 20 letters (slightly over one-third) relate to the exchange of representatives (England, Illinois, Minnesota, Maryland, North carolina, New Hampshire, Oregon, Nebraska, New Jersey, Rhode Island). Of the remaining two-thirds cover the largest category of action concerns letters to Councils regarding lateness in annual returns and payment of fees and dues to Grand Council (12 letters or 20%). The balance are reasonably evenly distributed: two letters refer to the form of a new Grand Council Certificate, two explain the transmission of a dispensation for the institution of Cyrus Council in Winnipeg, one set of letters concerns the formation of Morris Council, Perth, four letters acknowledge receipt of fees and dues, four advise members of the 1876 Assembly and one "permission" was issued so that a recently moved Canadian could become a member of an American Council (the one year residency not being expired). Two dispensations were issued to Winnipeg permitting the first TIM and first DM to be installed in a new Council without having filled the previous office. A special category of correspondence was initiated regarding the creation of a Canadian College of Rites (1 letter).
- 1877 4 items, all referring to Cryptic Rite matters: two refer to proceedings being sent to other Grand Councils and two refer to Councils.

- 1879 nil
- 1880 nil
- 1881 25 items, none of which refer to the Cryptic Rite. By this year, R. W. Bro. Nixon had become DDGM of Toronto District and 24 refers to the Craft and 1 to Royal Arch matters.
- 1882 11 items of which two refer to balloting of a member of Rehoboam Lodge for exaltation into King Solomons Chapter and one refers to a Lodge.

Two letters to the Sovereign Grand Councils (USA and London, UK) advising of the formation of the Imperial Grand Conclave of the Red Cross of Constantine of Canada on August 10, 1875, 10 letters to Ontario Conclaves to obtain membership and officer lists and two letters advising Col. W. J. B. McLeod Moore and T. D. Harington that they had been granted the rank of Past M. III. Grand Sovereign, .

[Note: the above letter refers to the formation of the Grand Lodge of Ontario. Brethren in London, Ontario had requested dispensation to constitute themselves as Eden Lodge, and, when the request was considered in July 1875 it was not granted. However, Eden Lodge met and initiated a candidate despite Grand Lodge's refusal to issue a dispensation. Members of the Lodge later met and declared their independence as the Grand Lodge of Ontario on February 10, 1876. The Grand Lodge of Canada immediately issued suspensions for the members, which totalled some 48 in number. The malcontents were expelled and appear to have continued irregular meetings. Only the Grand Lodge of Texas recognized Eden Lodge and the new Grand Lodge of Ontario, and even that recognition was withdrawn when Texas became aware of the circumstances. Some legitimate masons who had joined the illicit Grand Lodge were welcomed back to the Grand Lodge of Canada by 1879. By 1877 most of the original members of Eden Lodge sought reinstatement in the Grand Lodge of Canada and such requests, up to 1896, were not considered by the Grand Lodge of Canada. An agreement was eventually reached and all the property of the Grand Lodge of Ontario was transferred to the Grand Lodge of Canada in the Province of Ontario and all members of the Grand Lodge of Ontario were then accepted with the ranks which they had attained. By 1879 the seal of the Grand Lodge of Ontario had been submitted to the Grand Lodge of Canada, delivered and destroyed, thus allowing the Grand Master M. W. Bro. Hon. James Kirkpatrick Kerr, KC, to announce that the Grand Lodge of Ontario ceased to exist. The reason for the creation of this Grand Lodge of Ontario is also the reason for its failure — the personal gain sought by its leaders. These individuals decided that they would not submit to lawful central authority of the Grand Lodge and separated (when it did not agree to warrant Eden Lodge). They could only have failed. — Ed.]

We have not as succeeded, nor are we likely to succeed in establishing it at the last meeting of the Grand Council. Grand Conclave and Grand Lodge of Royal Ark mariners (word indecipherable) were passed in each body favorable to the formation of such Grand Council of Rites (see (word indecipherable) on Grand Council Procs) and the same Comps were elected to the principal offices in each of the orders. But on examining the situation clearly and going into details it was found impossible to effectively coalesce the three bodies into one, from the fact that Royal Arch Masons only are taken as candidates in two of those bodies and Master Masons in the other and again was found that it would interfere in some quarters with the friendly relations already existing between our own and other Grand Councils of Royal and Select Masters and also between our own and other Grand Conclaves of the Red Cross of Constantine (three words indecipherable) we came to the conclusion to carry on the three orders as formerly, but in order to facilitate matters as much as possible they meet at the same place and time that is the Grand Conclave is opened immediately after the Grand Council is closed and the Grand Lodge of Royal Ark Mariners immediately after the Grand Conclave is closed. The Companions who are sent as representatives, as a rule, belong to each of the orders and for this year at least the principal Grand Officers are the same. Our idea I think was good and many of our prominent members have not entirely given it up yet. I would draw your attention to the Constitution which provides that no person can be made a Mason unless he has resided one year in the jurisdiction of the Lodge to which he seeks admission &c.

There is also a clause which provides that no Lodge can initiate a candidate whose residence is nearer the jurisdiction of another Lodge &c.

I presume it was with this letter clause in view that Zeredatha Lodge preferred the complaint. I apprehend however that the word residence in the latter clause interpreted Masonically means residence for at least twelve months.

I therefore hold 1st That every person is under the jurisdiction of some Lodge

2nd As a person cannot be made a Mason by a Lodge until he has lived or resided at least one year within its jurisdiction, that until the year has elapsed he must necessarily be under the jurisdiction of the Lodge nearest to which he formerly resided

3rd That a Lodge balloting for and initiating any person who formerly lived in their jurisdiction but who has been residing for a less time than one year (say seven months) in the jurisdiction of another Lodge, does not commit a Masonic offence.

I therefore decide that in the case referred to me Zeredatha Lodge has no just cause of complaint against Manitoba Lodge. I am dear Sir & W. Bro.

I also beg to draw the attention of the M.W.G.M. to No. 8 Art LVII, The best authorities on Masonic Parliamentary held that there can be no such mention in a Masonic Lodge as the previous question and that these are for motions in order after an amendment to an amendment Viz to commit to postpone indefinitely, to postpone to a certain time and to lie on the table. With these exceptions I beg to recommend the revised bye laws to the favorable consideration of the M. W. the Grand Master.

To J. Ross Robertson, Grand Supt of the Toronto District, Grand Chapter of Royal Arch Masons of Canada

I beg to appeal against the actions of the 1st Principal Z of King Solomons Chapter, No. 8 GRC, in balloting on the Petition of S. Palmer of Rehoboam Lodge No. 75 GRC for the following reasons

- 1 As a member of the Chapter I acquainted the 1st Principal Z in conversation with the fact that I did not consider the applicant a fit and proper person to receive the degrees of Royal Arch Masonry and that I decidedly objected to his admission in King Solomons Chapter. I consider that should have been sufficient without my giving the nature of my objections which I could not do without violating the confidence reposed in me by a Brother Mason.
- 2 The applicant is not three months a Master Mason as provided by the Constitution having received his three degrees at an Emergent Meeting of Rehoboam Lodge held in the month of November.
- 3 The meeting of the Chapter at which the application was balloted for was summoned at 7 oclock and the Chapter was opened before that hour.
- 4 I applied for admission to the Chapter before the Candidate was balloted for and was not admitted.

In view of the above facts I submit that the action of the 1st Principal Z was both unconstitutional and unmasonic and pray that his decision may be set aside and that he be instructed not to admit the said Brother S. Palmer as a member of King Solomons Chapter or confer upon him the degrees conferred by the Grand Chapter of Canada.
